  - **One Payment** - Full payment of the amount on line 5 below must be received by SANY on or before **September 30, 2025.**
  - **Three Payment** - Three equal payments totaling the amount indicated on line 7 below. The first payment must be received by SKI NY on or before September 30, 2025 and a one-time installment payment fee of \$25, this is payable with the first installment. The second payment is due on or before December 31, 2025 and the final installment is due on or before January 31, 2026.
  - **Terms:** Net 30 days; a 1% per month finance charge will be applied to all amounts 60 days or more past due.
